On June 16, 2023 I responded to 6200 Cracker Swamp Road (residence) in reference to a battery complaint which took place at 2980 Collins Avenue (First Coast Technical College) on June, 01 2023.

Upon my arrival, I made contact with James Owen Parham (victim) and Forrest Edward Parham (Victim). James and Forrest advised they were attending a Republican meeting at First Coast Technical College. James advised there was a disagreement between he and Blake Martin Paterson (Suspect). James advised Blake had hired an off-deputy to attend the meeting for safety. James advised that Blake demanded the deputy to escort James out of the meeting even though James had a right to be there. James advised that the deputy appropriately reminded Blake that he could not do so as it would be a constitutional rights violation unless James was breaking a law which he was not. James advised that Blake then exited the meeting and called additional law enforcement on scene despite there not being an actual emergency. James advised that once Blake returned, Blake walked past James to return to Blake's seat and while passing James, Blake intentionally placed two hands on James and gave a gentle push. This event was captured on Forrest's cell phone as he was recording due to rising tensions in the room.

Forrest advised that while he was filming, Charles Glenn Williams (Suspect) walked up behind Forrest, reached over Forest's shoulder and snatched the phone out of his hands then throwing it onto the ground. Forrest advised his first instinct was to strike Charles in self-defense, however decided not to and simply yelled at him instead. Forrest advised he was able to retrieve his phone which sustained no damage from this incident. Forrest advised there was also a video of this incident which was captured on his phone.

While on scene, Forrest provided me the videos which captured both incidents by "air dropping" them to my dedicated work phone. These videos were submitted to Digital On Q per agency policy. James and Forrest filled out "blue cards" and were provided victims rights guides as they victims for this incident. The entirety of my interaction with James and Forrest was captured on my agency body camera. A warrant affidavit will be forwarded to the State Attorney's office for further review for simple battery for Blake and robbery by sudden snatching (no weapon) for Charles. No further action taken by this deputy regarding this incident at the time of this report.
